The Annual Region 12 Training Seminar will be held at the Bally's Park Place Casino/Hotel at 1900 Boardwalk, Atlantic City NJ on February 24, 25, 26, 27, 2019. Arrival will be on Sunday February 24th. The seminar will begin on Monday, February 25th and will conclude on Wednesday, February 27, 2018.

Reservations are to be made directly with Bally's Park Place by calling 1-888-516-2215 and identifying yourselves with the National Assoc of Letter Carriers and reference Group Code SB02NA9 Bally's and request the \$50.00 room rate. All reservations made via the telephone call center will be assessed a fee of \$15.00 plus current sales tax, per person. This fee will not apply to reservations made via the internet.

An advanced payment of one (1) night's lodging is required. The cost of the hotel room is \$50.00 single/double plus taxes and other fees. Additional persons will be charged at a rate of \$30.00 per person, per night with a maximum of four (4) persons per guest room.
